3) Marysville Fire District Monthly Report

The average response time for October was 8 minutes 39 seconds. There is nothing outstanding to report. The Council asked about the average response time, Chief Vander Pol explained that this is the overall response time for the district. Occasionally an outlier can skew the total average. The Council has no further questions.

4) Tulalip Police Department Monthly Report

Chief Sutter apologizes for the monthly statistics report not being included in the agenda and announces that there are no significant events to report, then continues to explain the safety precautions in place for the upcoming holidays. With the Village Lights event and the Seattle Premium Outlets Black Friday Shopping event, we have adjusted our patrols. The Council asked about traffic controls and coverage details. Chief Sutter responded with coverage plans and Seattle Premium Outlets has rented signage to help alleviate traffic congestion.
