3) Marysville Fire District Monthly Report Accepted

During the month of August, Marysville Fire responded to calls in the Village 56 times, 43 of those calls were EMS related and 17 of those calls resulted in transport. The average response time was 9 minutes, 6 seconds. The district is looking at adjusting our staffing needs and transition from part-time to full-time, looking into approve new levies to offset the increased cost needed to support the staffing transition, and to support building a new firehouse. The Council asked if calls for service are included in their decision to build a firehouse in certain areas more than others. Yes. Also included is the response time. The District has a goal of 5 minutes or less to respond to calls because there are challenges to life support as the time increases from 5 minutes. In addition to that update, the District will meet with GM Napeahi to discuss the 2023 Service Agreement.

4) Tulalip Police Department Monthly Report

Chief Sutter provides an overview of the crime statistics and report by first pointing out the color coding system in the report, and the difference between theft and shoplifting. Councilman Shopbell asked Chief Sutter if he is working with staff to create new strategies to combat the theft and increase public safety within the Village. Chief Sutter explained that he has been working on ways to keep experienced officers as well as recruitment. President Posey asked if other municipalities have comparable wage scales. Chief Sutter confirmed that other municipalities have access to a pension plan, grant funding access, and the Department is looking into ways to meet those needs successfully.
