Public Safety & Justice

Discussion: Chief McFalls, President Posey, Councilman Shopbell, Chief Sutter, Cameron Reyes.

3) Marysville Fire District Monthly Report

Chief McFalls welcomes the new Council members and hands out pens and Challenger coins to the Council.

Then proceeds to explain that he missed last month's meeting due to training. In March 2022, the statistics show

we may have reached the end of the pandemic because calls for service are back to pre-pandemic totals. The average response time increased, likely due to a train delay. One train delay can increase the response time significantly. Marysville Fire District is working closely with Tulalip Bay Fire, collaborating how to service the Tulalip Community. Councilman Shopbell asks where the service boundary is for both districts. Chief McFalls replies that the border is at 12th Avenue and discussed how to service the community as a whole when the Santa and Easter Bunny events drive-thru the community.

4) Tulalip Police Department Monthly Report

Chief Sutter apologizes for not having a bar graph to view the monthly statistics, and explains that office staff may have been confused when asked to include a summary of activity to the agenda. Chief Sutter details the activity officers have responded to during the month of March. Officers have increased presence in the Village, moving from the Remedy Tulalip location to other retail locations within the Village. They continue to work with Seattle Premium Outlets, and other retailers, to discuss employee safety tips and asset management. Those meetings will occur regularly. Chief Sutter is happy to announce that Tulalip Police Department (TPD) acquired a canine officer that specializes in narcotics. The canine officer will be paired with Officer Jordan Jira and will begin a training program. We are excited to have him and that additional resource in the field. TPD has a Community Response team that is actively working in the field. We have increased their efforts to support the MMIW (Missing and Murdered Indigenous Women) movement and working with the FBI on missing women from the Tulalip community. We had three (3) officers completing the training program, and two (2) will graduate. The third member was injured during training and is unable to complete the program, but will return at a later date once recovered. Councilman Shopbell asks if this report is different that the report presented to the full Board. Chief Sutter replies yes. This report is specifically for crime statistics inside Quil Ceda Village. President Posey asks if the crime rates fluctuate. Chief Sutter answers yes. It does have ebb and flow, the hours will vary from opening to closing, and higher rates of activity vary from month to month. Councilmen Shopbell asks if there is a minimum threshold to make an arrest. Chief Sutter replies no and asks if anyone has additional questions. Cameron Reyes asked Chief Sutter about the process to remove unoccupied tents from property owned by the Tribe because an officer refused to aid him by removing a person(s) tent that was set up near a pathway. Chief Sutter explained that they cannot just dispose of a person's property. That doing so would require an imminent threat to disable the tent. Please continue to contact us when you need to.

14) Monthly Finance Report

Discussion: Mark Sabo, CFO

Mark Sabo provides an overview of the finance report by pointing out the income and expenses for Quil Ceda Village. The income is collected from tax dollars, primarily cigarette taxes and fuel taxes. We also collect a Sales & Use, Restaurant, Hotel & Lodging, Hotel & Occupancy tax. The cigarette are pacing just below projections at twenty-two percent, the fuel tax income is pacing at twenty-four percent. Next is the Project Report, we have closed out several projects in Utilities and old Transportation projects. There will be some funding left over from the QPARK project, that was intended to expand the parking lot here at Quil Ceda Village administration, but the cost did not outweigh the benefits. Staff asked if the Council for direction, to either move the funding to Unspent Funds or to the New Administration building construction. The Council directs staff to move the funding towards a new building.

Included in your packet is an architect and engineering proposal to do the design work for a new administration building at 27th Avenue and 88th Street. This is the location that was chosen for the new building when we were going to design and build the Justice Center. During team meetings with the Legal and Police Departments, the project reached a stalemate. Then funding was pulled to cover other projects. We have now reached a point

where the need to move into a new administration building is essential. Councilmember Contraro asks staff if the request was put out to bid. Staff replies no. She asks why staff is sole sourcing the project. GM Napeahi states that we used the same firm that the casino has retained for services for the next five years, but staff can complete a Request for Qualifications before continuing.
