### **4) Marysville Fire District Monthly Report**

During the month of September, the Marysville Fire District responded to 27 calls for service, 20 were EMS related and 6 resulted in medical transport. Our average response time was 7 minutes 49 seconds. We have seen a plateau in virus related calls, and a reduction countywide. Chief McFalls explains that there was a fire at Cabela's in the maintenance area. The building sustained more water and smoke damage, than fire damage. The fire report is ready and will be remitted to Quil Ceda Village by the end of the week. Cameron Reyes thanks Marysville Fire for their support.
